Note: The NATO Status of Forces Agreement (SOFA) between Italy and the United States prohibits the hiring of any person who holds Italian citizenship and is considered a Dual National by the Italian Government into any U.S. position. Those U.S. citizens who are considered "ordinarily resident" in Italy are also ineligible for employment by U.S. commands and activities in Italy.

INTRODUCTION

The purpose of this position is to provide professional support to the comprehensive program of recreational Fleet and Family Readiness opportunities for USN active duty, home-port ship, retired military, DOD Civilians, DOD contractors and their family members, visiting ships and guests.

DUTIES AND RESPONSIBILITIES

The incumbent performs a wide variety of tasks, which furnishes direct services to the public and supports FFR sponsored programs, services and events. Serves as a primary front line customer service representative of the overall program and as such, must continually present information in a highly professional and customer friendly style.

Assists patrons with the physical resources offered within the Fleet and family Readiness Center (use of computers and Wi-Fi, videogames; PS2, PS3 Xbox, Pool table, ping-pong table).

Assists in highlighting special emphasis for programs and events, by disseminating information on all services special promotions.

Registers and collects fees from patrons for organized ITT tours, Community Events, Single Sailor/Liberty, instructional classes and other related MWR program.

Performs cashier duties and is designated to maintain an authorized change fund.

QUALIFICATIONS & REQUIREMENTS

Six (6) months of general experience and six (6) months of specialized experience.

General experience is any type of work that demonstrates the applicant's ability to perform the work of the position.

Specialized experience is that which has equipped the applicant with particular knowledge, skills and abilities (KSA's) to perform successfully the duties of the position, and that is typically in or related to the work of the position (e.g. Group leader/counselor in community centers, sales or stock clerk in recreation supply/equipment shop, aid in resort recreation service, etc.).

OR

Successfully completion of two (2) years of education above the high school level in any field for which high school graduation or the equivalent is the normal prerequisite, that included at least 12 semester hours of courses related to recreation.

KNOWLEDGE REQUIRED:

Possess extraordinary people interaction, customer service, organizational and teambuilding skills.

Holds above average skills in speaking, reading and writing the English language.

Ability to produce work in a highly energetic and comprehensive program atmosphere.

Skills in operating cash register, computer, microcomputer, fax machine, projectors and related equipment. Must be competent in Microsoft Word and other computer program knowledge.

Incumbent should be familiar with the needs and interests of the military and DOD Community.

Must maintain a current Driver's license American & Italian translation, to operate a 9-passengervan.

Must be able to work flexible work hours days, nights and weekends.

- Applicants who hold both U.S. and Italian citizenship are not employable by the U.S. Forces in Italy.
