# MEMORANDUM FOR THE RECORD

From: Commanding Officer, U.S. Naval Support Activity, Naples, Italy Subj: NSA NAPLES INSTALLATION ADVISORY COMMITTEE (IAC) MEETING MINUTES 10 DECEMBER 2025

- 1. The NSA Naples Installation Advisory Committee (IAC) meeting was held on 10 December 2025, at 1600 in the NES Library and via TEAMS. The following is a summary of the meeting.
- 2. CALL TO ORDER. The meeting was called to order at 1600 by the Meeting Chairperson, Captain John Randazzo, NSA Naples Commanding Officer. Captain Randazzo welcomed parents, volunteers, and leaders from NSA Naples and DODEA, emphasizing the IAC's purpose in discussing issues impacting both schools with a specific link to NSA Naples.

- $4.\ 30/60/90$  UPDATES. The School Liaison and DODEA Administrative Team highlighted 30/60/90 events, early withdrawal dates, the CYP Youth Sports registration deadline (19 Dec), and upcoming CYP activities.

#### 5. NMHS REPORT.

#### a. Facilities:

- (1) NMHS External Door Replacement: Phase 1 began in November 2025 (retrofit locks needed). Phase 2 is to begin in March 2026.
- (2) HS Gym Bleachers: Wheels installed, but motors are not operable (not covered by Mirabella). DODEA will purchase; Mirabella can install. Bleachers can be moved manually.
- (3) Culinary Arts Program: Classes to be held at USNH Naples. A TF1 has been submitted to DODEA for design and funding to replace fire suppression equipment and vent fans. A lease modification is needed with Mirabella due to the vent fan cleaning requirement (every 6 months).

- b. Fall Sports: Near final games before Euros, strong performances reported.

# 6. NES REPORT.

- a. Parent Engagement: Parents are invited to join students for lunch and recess (sign in at the office).
- b. Student Council Representation: Representatives were unable to attend this meeting and will be introduced at the next IAC.
  - c. NES Priorities:
    - (1) Priority 1: Pest Control in Art Room: Completed.
- (2) Priority 2: Traffic Safety: Instruction completed. Infographic forthcoming. TF1 developed for scope and funding. Physical infrastructure changes planned for Fall 2026.
  - (3) Priority 3: Elevator: Awaiting parts through Mirabella.
- d. After-School Clubs: Actively occurring. New clubs starting in January include ASL, Book Club, Google Suites, and Math Breakfast Club.

# 7. COMMANDING OFFICER REPORT.

- a. Traffic Safety Update: NSA Naples is responsible for infrastructure upgrades, traffic control, and enforcement. TF1 approved with funding for a raised crosswalk, sidewalk removal, and a single-arm swing gate. Completion is expected in the final quarter of FY26. Temporary barriers will be placed during AM drop-off and PM pick-up. No vehicles are allowed near busses. An infographic on traffic flow will be rolled out in January 2026.
- b. Non-DODEA Facilities Updates: Road repairs are underway, the fitness center renovation is in January, and the pool heater is progressing. Mirabella is significantly behind (1.5 years) on repairs and preventive maintenance. Concerns have been elevated.
  - c. NSA Naples Manning Update:
    - (1) Installation Manning: <70%</pre>
    - (2) Housing Staff: 87% (New Director on Board)
    - (3) Fire: 73% (several inbound)
- (4) MWR: 80% (Janitor on board at SS Fitness Center, major issues at CAPO Fitness Center and Pool)
  - (5) CYP: 90% (LN hires worked well, working to keep)

# 8. SCHOOL LIAISON REPORT.

- a. Naples Multi-Disciplinary Team (MDT): Instruction in development. Marketing to be developed upon approval. Final Draft to ICO by 31 Dec 25.
- b. Free- and Reduced-Meal Program: Applications are being processed. Income verification is occurring through CNIC. Timely response is required to avoid removal from the program.

- b. A question was raised about responsibility for low-hanging trees. The ICO explained that an arborist is scheduled to cut the tree.
- c. A parent question was raised about School Lunch Discrepancies. The SL will post to the CYP Facebook page to ensure the community is aware of the process to address billing concerns.
- d. A parent concern was raised about lights being out in a housing quad. The ICO explained the repair process will take time.
