INTRODUCTION This position is located in the Aquatics branch of the Fitness and Recreation divisions, MWR, US Naval Support Activity Naples, Italy. The incumbent primarily serves as a lifeguard and provides assistance in the operations and maintenance of the fitness program.

DUTIES AND RESPONSIBILITIES

Performs work in the swimming program as an aid to the Aquatics Manager. The incumbent safeguards the pool at all times, supervises swimmers and bathers, and stays fully alert for any situations which may pose hazards to a person's life, health, or safety. Warns swimmers of unsafe conditions and actions through enforcing and educating patrons of swimming and bathing regulations. Takes action to remove hazards or have the individual (s) causing hazards to leave the pool area or cease the activity.

Rescues swimmers in distress and promptly administers emergency first aid as needed. Calls for medical assistance when needed. Scans pool area for any possible environmental dangers such as falling object, defective equipment, and slippery areas and intervenes or notifies Aquatics Manager if necessary. Uses first aid kits, lifesaving equipment, and may occasionally perform Cardiovascular Pulmonary Resuscitation (CPR) or Automated External Defibrillator (AED). Records any first aid or distressed swimmer in a log book, fills out injury report and reports it to the Aquatics Manager or Chain of Command. Maintains pool records, reports and information regarding the following: hourly patron attendance, water chemistry, daily weather conditions and incidents.

Performs work as an instructor for Water Safety/Water Aerobics/Other Water Related Classes and will be in charge of instructing classes (all ages) throughout the year. Participates and assists with programming and instructing for programs and all special events. Conducts Fitness facility customer orientations.

Oversees Carney Park and Support Site daily pool operations including monitoring and assisting the youth programs, maintaining facility safety, and assists with in-services for all staff.

Maintains the cleanliness of the pool and the pool area. Makes periodic checks of pool water chemical levels according to an established schedule and informs Public Works and Aquatics Manager if levels are not within industry standard.

Assists in maintaining the fitness, sports and aquatics area clean and free from any hazards. Removes debris from pool water and deck, brushes and vacuums pool sides and bottom, and scrubs pool scum line. Sweeps and hoses down pool deck area. Keeps counter and workspaces clean and neat, cleans and sanitizes equipment, washes and folds towels for customer usage. Makes periodic checks of the locker rooms and performs light housekeeping duties to maintain order and cleanliness. Gathers trash and debris and removes to the appropriate depository receptacles.

QUALIFICATIONS & REQUIREMENTS:

Must be able to pass pre-hiring swimming test.

Applicants must be able to pass full certification course for American Red Cross Lifeguard Training, R-17. Course and certificate includes CPR/AED and First Aid (Failure to pass will be cause for dismissal).

Must have a current Italian Lifeguarding Certificate. CERTIFICATE NUMBER MUST BE INDICATED ON THE APPLICATION.

In addition to the required certificates applicants must have one (1) year of general experience, which indicates ability to acquire the particular knowledge, and skills needed to perform the duties of the position.

OR

Successful completion of two (2) year of education above high school level in any field for which high school graduation or the equivalent is a prerequisite may be substituted for the experience at the Ua-06.

To receive credit, you must fill out the required fields on the “Employment Application” form.

ADDITIONAL REQUIREMENTS:

Selectee will be required to favorably pass a security background check and a pre-employment medical suitability examination as a condition of employment.

Applicants must be able to read, write and speak fluently in both English and Italian.

Subject to irregular work schedule that may include night shifts, rotating shifts, weekends and/or holidays.
